



VOLUNTEER AGREEMENT

During the football/cheer season, I, _____, agree to fulfill the BRJB volunteer requirement.

- **Standard Registration:** 10 volunteer hours per child (maximum of 20 hours per family).
- **Scholarship Families:** 20 volunteer hours are required, regardless of the number of participants.

I understand that I am required to submit **three (3) volunteer checks of \$150.00 each**. Unless I elect the Volunteer Opt-Out option, I am required to sign up for a minimum of **six (6) volunteer hours** prior to or during **Document Collection/Equipment Handout**. **Equipment will not be issued until the required six (6) volunteer hours have been scheduled**. Remaining volunteer hours must be scheduled as volunteer opportunities become available.

Volunteer Hour Deadlines

Deadline	Standard Families	Scholarship Families
August 30	3 hours	7 hours
October 5	6 total hours	14 total hours
November 15	10 total hours	20 total hours

Volunteer hours must be completed by the deadlines listed above. If I have not completed the required volunteer hours by the applicable deadline, I authorize BRJB to deposit **one (1) \$150.00 volunteer check on the first Friday following that deadline**.

Volunteer shifts must be completed by the registered parent/guardian or another approved adult. Families wishing to have another individual volunteer on their behalf must notify and receive approval from the BRJB Volunteer Coordinator in advance.

Volunteer shifts cancelled less than **24 hours** before the scheduled shift, or missed without notice, are the responsibility of the volunteer. If a volunteer is unable to work a scheduled shift with less than 24 hours' notice, it is their responsibility to find an approved replacement and notify the Volunteer Coordinator. Failure to do so will result in **one (1) warning**. A second occurrence will result in the immediate deposit of **one (1) \$150.00 volunteer check**.

Volunteer hours will be tracked by the BRJB Volunteer Coordinator using the league's volunteer database. Once a volunteer check has been deposited, it is non-refundable.

If all required volunteer hours are completed by the final deadline and all BRJB-issued equipment has been returned in satisfactory condition, all uncashed volunteer checks will be returned.

VOLUNTEER OPT-OUT

I, _____, elect not to participate in the BRJB volunteer program and agree to pay the **\$450.00 Volunteer Opt-Out Fee** in lieu of completing volunteer hours.

I understand this fee is non-refundable.

EQUIPMENT AGREEMENT (FOOTBALL ONLY)

During the football season, I, _____, will receive a helmet, shoulder pads, equipment bag, guardian cap, practice jersey, and game jersey for my player.

I agree to keep all BRJB-issued equipment in good condition and return it at the end of the season. I agree to wash all jerseys and remove all stickers from the helmet prior to returning equipment.

I understand that I am required to submit **one (1) equipment check in the amount of \$250.00** prior to receiving equipment. The equipment check will be returned once all BRJB-issued equipment has been returned in satisfactory condition.

If any equipment is lost, not returned, or returned damaged beyond normal wear and tear, I authorize BRJB to deposit my equipment check to cover the cost of repair or replacement.
